UPDATE

(Route 58) – A contractor will have alternating lane closures eastbound on Route 58 between the Nansemond Parkway overpass and the Route 58 on ramp at Portsmouth Boulevard for a milling and paving operation. Milling will take place overnight from 7 p.m. to 5 a.m. and the paving will take place daily from 9 a.m. to 4 p.m., November 13th through November 18th.

ROAD CLOSURES AND POSSIBLE TRAFFIC DELAYS

SUFFOLK, VA (November 10, 2016) The following roads in the City of Suffolk will have closures that could cause delays, Thursday, November 10, 2016, due to construction and maintenance projects.

New Projects:

(Godwin Boulevard) – A contractor will have a shoulder closure on the Godwin Boulevard on-ramp from westbound Route 58 and a westbound lane closure on the overpass on Godwin Boulevard from 7 a.m. to 4 p.m.

(Badger Road) – Suffolk Department of Public Works will have the 2900 block of Badger Road closed for bridge repair from 9 a.m. to 3 p.m.

(Bridge Road) – A contractor will have a southbound lane closure in the 2600 block of Bridge Road for utility work from 9 a.m. to 12 p.m. This work zone will be intermittent for the next 6 months.

(Route 58) – A contractor will have a mobile operation westbound on Route 58 between SPSA and the Route 13/32 Bypass for vegetation maintenance from 8 a.m. to 6 p.m.

(North Main Street) – A contractor will have an outside lane closure northbound and southbound on North Main Street between VDOT and Murphys Mill Road until 2:30 p.m. and then switch to two inside lanes. This closure will be 24 hours until further notice.

(Gittings Street) – A contractor will have a lane closure in the 800 block of Gittings Street from 9 a.m. to 12 p.m.

Upcoming Projects:

(Godwin Boulevard) – A contractor will have a westbound right lane closure in the 3100 to 3400 block of Godwin Boulevard for a turn lane installation from 12 p.m. to 4 p.m., November 14th.

(Moore Avenue) – A contractor will have a lane closure in the 300 block of Moore Avenue from 9 a.m. to 4 p.m.

Ongoing Projects:

(West Riverview Drive) – A contractor has West Riverview Drive closed between Butler Avenue and North Broad Street for road and washout repair. Accommodations will be made for residents and emergency vehicles.

(Arthur Drive) – A contractor will be demolishing and reconstructing bridges over Spivey Run and Langston Swamp on Arthur Drive. A detour will be in place to direct motorists with the detour in place. This closure will remain until the estimated completion date of January 31, 2017.

(Highland Avenue) – A contractor will be installing a new pump station and sewer and water lines on Highland Avenue between Kingsboro Street and the end of Highland Avenue at the cul-de-sac. This project will continue through June 2017.

(Seaboard Trail) – A contractor will have the Seaboard Trail from Main Street to Moore Avenue closed to all pedestrians until further notice. The contractor is estimating a December completion date.
