UPDATE

The teen wanted in connection with seven tampering and larcenies from vehicles turned himself into Suffolk Police yesterday. The sixteen year old was arrested and charged with two counts of grand larceny, two counts of conspiracy to commit larceny, seven counts of entering a vehicle to commit a crime, three counts of petit larceny and three counts of attempted petit larceny.

He is currently being detained at Chesapeake Juvenile Services.

SUFFOLK, VA (July 8, 2011) Kempton D. Whitney turned himself into Suffolk Police this afternoon. Police continue to look for the sixteen year old suspect in this case. Detectives secured a court order today that allows the release of the teen's information and photo.

Shai L. Winfield, of the 6000 block of College Drive, is wanted for two counts of grand larceny, two counts of conspiracy to commit larceny, seven counts of entering a vehicle to commit a crime, three counts of petit larceny and three counts of attempted petit larceny.

SUFFOLK POLICE SEEKS SUBJECT IN LARCENIES FROM CARS

SUFFOLK, VA (July 6, 2011) Suffolk Police are asking for assistance in locating a subject wanted in connection to seven larcenies from vehicles or tampering with vehicles that occurred yesterday morning. Police received a call on the morning of July 5, 2011, in reference to two males observed entering vehicles in the Burbage Grant community. The subjects fled prior to police arrival.

A description of the suspect vehicle was broadcast. Police stopped the vehicle a short distance from the scene of the larcenies. Two males fled the vehicle on foot and were not apprehended. Items were located in the suspect vehicle that had been stolen from cars in the community.

Police have identified two subjects in connection with the incidents and are attempting to locate them. Seventeen warrants are on file for Kempton D. Whitney, age 20, of the 100 blk. of Butler Street in Portsmouth. Charges include: grand larceny, several counts of petit larceny, contributing to the delinquency of a minor and several counts of entering or setting a vehicle in motion. Petitions have also been secured for a sixteen-year-old male, whose identification cannot be released due to his age.
