UPDATE

SUFFOLK, VA (August 13, 2019) - Suffolk Police advise that an additional subject has been identified following their investigation related to the alleged Commercial Armed Robbery of the McDonald's in the 6200 block of College Drive on August 9, 2019.

Warrants have been secured for the arrest of Ebonie Michelle Blount, age 33, of Chesapeake, for Grand Larceny, Conspiracy to Commit Larceny, and Conspiracy to Commit a Felony in connection with this case. Photo is attached.

UPDATE

SUFFOLK, VA (August 12, 2019) - Suffolk Police advise that following their investigation two individuals have been arrested related to the alleged Commercial Armed Robbery that was reported to have occurred during the early morning hours on August 9, 2019 at the McDonald's in the 6200 block of College Drive.

Latrivia Yvette Holmes, age 38, of Portsmouth, a Manager at the McDonald's where the alleged Commercial Armed Robbery was reported, was arrested the evening of August 9, 2019 on charges including Robbery: Business, Embezzlement (2 counts), Conspiracy to Commit a Felony, False Statement During an Investigation, and False Police Report.

Latesha Monique Holmes, age 40, of Chesapeake, was arrested the evening of August 9, 2019 on charges including Robbery: Business (2 counts), and Grand Larceny (2 counts).

Mug shots for both women are attached. They are currently being held without bond at the Western Tidewater Regional Jail.

The investigation remains ongoing at this time.

POLICE INVESTIGATING COMMERCIAL ARMED ROBBERY

SUFFOLK, VA (August 9, 2019) – Suffolk Police are investigating a Commercial Armed Robbery which occurred earlier this morning, Friday, August 9, 2019.

Emergency Communications was contacted advising of the incident that occurred at 4:33 a.m. at the McDonald's in the 6200 block of College Drive.

Upon preliminary investigation it was determined that a male with a knife forced his way into the building as they were opening and demanded money. He was further described as approximately 6'2" and wearing all black clothing. The subject fled on foot with an undetermined amount of currency. There were no injuries.

The investigation remains ongoing at this time and surveillance video photos will be provided when available.
