I am writing regarding the Suffolk Commonwealth's Attorney's Office's recent 8<sup>th</sup> annual Forensics Camp. The office provided the FREE Forensics Camp for Suffolk students, ages 12-15 during the month of June. The Camp was very successful, graduating a total of 52 students.

The students were divided into 5 teams that worked mock crime scenes collecting evidence and gave reports at the closing Graduation ceremony. The Forensics Camp taught the students about observation, photography, evidence collection, preservation and testimony in court. The curriculum was designed to educate students about the study of forensics through criminal law. The Forensics Camp educated the students on the specific evidence needed by the Commonwealth's Attorney's Office and how to properly collect evidence to successfully prosecute cases. The students became increasingly aware and understood the realities of criminal cases through forensics.
